(d) As a condition of eligibility for medical assistance, a recipient is deemed to have assigned to the Secretary of Health and Mental Hygiene of the Secretary's designed any rights to [medical care support as determined by a court or administrative order and any rights to payment for medical care from health insurance as defined in Article 48Å, § 66 of the Code] PAYMENT FOR MEDICAL CARE SERVICES FROM ANY THIRD PARTY WHO HAS THE LEGAL LIABILITY TO MAKE PAYMENTS FOR THOSE SERVICES, TO THE EXTENT OF ANY PAYMENTS MADE BY THE DEPARTMENT ON BEHALF OF THE RECIPIENT.

490W:

- (A) (1) IN THIS SECTION THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED:
- (2) "COURT OR ADMINISTRATIVE ORDER" MEANS AN ORDER ISSUED BY A COURT OR ADMINISTRATIVE AGENCY THAT:
- (i) CREATES OR RECOGNIZES THE RIGHT OF A CHILD TO RECEIVE BENEFITS UNDER A PARENT'S HEALTH INSURANCE COVERAGE:
  - (II) CLEARLY DESCRIBES THE COVERAGE TO BE PROVIDED; AND
- (III) SPECIFIES THE PERIOD OF TIME TO WHICH THE ORDER
- (3) "HEÀLTH ÍNSÜRANCE COVERAGE" MEANS ANY TYPE OF HEALTH CARE COVERAGE UNDER WHICH MEDICAL CARE SERVICES CAN BE PROVIDED TO THE CHILD THROUGH AN INSURER.
