- PRIOR TO THE PAYMENT OF ANY FUNDS TO THE BOARD OF COUNTY COMMISSIONERS OF ALLEGANY COUNTY UNDER THE PROVISIONS OF THIS ACT FOR THE PURPOSES SET FORTH IN SECTION 1(3) ABOVE, THE BOARD OF COUNTY COMMISSIONERS OF ALLEGANY COUNTY SHALL PROVIDE AND EXPEND AT LEAST AN EQUAL AND MATCHING FUND OF \$541,000. THE BOARD OF COUNTY COMMISSIONERS OF ALLEGANY COUNTY HAS UNTIL JUNE 1, 1996, TO PRESENT EVIDENCE SATISFACTORY TO THE BOARD OF PUBLIC WORKS THAT THE MATCHING FUND WILL BE PROVIDED. IF SATISFACTORY EVIDENCE IS PRESENTED, THE BOARD SHALL CERTIFY THIS FACT TO THE STATE TREASURER AND THE PROCEEDS OF THE LOAN SHALL BE EXPENDED FOR THE PURPOSES PROVIDED IN THIS ACT. IF THIS EVIDENCE IS NOT PRESENTED BY JUNE 1, 1996, THE PROCEEDS OF THE LOAN SHALL BE APPLIED TO THE PURPOSES AUTHORIZED IN § 8-129 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
