- (10) COMMITS ANY ACT OF UNPROFESSIONAL CONDUCT, AS DEFINED BY THE RULES AND REGULATIONS OF THE BOARD, OR VIOLATES THE CODE OF ETHICS ADOPTED BY THE BOARD;
 - (11) PROVIDES PROFESSIONAL SERVICES WHILE:
 - (I) UNDER THE INFLUENCE OF ALCOHOL; OR
- (II) USING ANY NARCOTIC OR CONTROLLED DANGEROUS SUBSTANCE, AS DEFINED IN ARTICLE 27 OF THE CODE, OR OTHER DRUG THAT IS IN EXCESS OF THERAPEUTIC AMOUNTS OR WITHOUT VALID MEDICAL INDICATION:
- (12) IS DISCIPLINED BY A LICENSING OR DISCIPLINARY AUTHORITY OF ANY OTHER STATE OR COUNTRY OR CONVICTED OR DISCIPLINED BY A COURT OF ANY OTHER STATE OR COUNTRY FOR AN ACT THAT WOULD BE GROUNDS FOR DISCIPLINARY ACTION UNDER THIS SECTION;
- (13) PRACTICES DIETETICS WITH AN UNAUTHORIZED PERSON OR SUPERVISES OR AIDS AN UNAUTHORIZED PERSON IN THE PRACTICE OF DIETETICS;
- (14) WILLFULLY FAILS TO FILE OR RECORD ANY REPORT OR RECORD IN THE PRACTICE OF DIETETICS:
- (15) (14) WILLFULLY FAILS TO FILE OR RECORD ANY REPORT <u>OR RECORD</u> AS REQUIRED BY LAW <u>IN THE PRACTICE OF DIETETICS</u>, WILLFULLY IMPEDES OR OBSTRUCTS THE FILING OR RECORDING OF THE REPORT <u>OR RECORD</u>, OR INDUCES ANOTHER TO FAIL TO FILE OR RECORD THE REPORT OR RECORD;
 - (16) (15) SUBMITS A FALSE STATEMENT TO COLLECT A FEE:
- $\frac{\mbox{(17)}}{\mbox{(16)}}$ is Professionally, Physically, or Mentally incompetent; $\underline{\mbox{OR}}$
- (18) (17) PROMOTES THE SALE OF DEVICES, APPLIANCES, OR GOODS TO A PATIENT SO AS TO EXPLOIT THE PATIENT FOR FINANCIAL GAIN: OR
- (19) BEHAVES IMMORALLY IN THE PRACTICE OF DIETETICS. 5-502.

Subject to the evaluation and reestablishment provisions of the Maryland Program Evaluation Act, this title and all regulations adopted under this title shall terminate and be of no effect after July 1, [1995] 2005.

(I) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (E) OF THIS SECTION, ON OR BEFORE JULY 1, 2004, AN EVALUATION SHALL BE MADE OF THE STATE BOARD OF DIETETIC PRACTICE ESTABLISHED UNDER THE HEALTH OCCUPATIONS ARTICLE AND THE REGULATIONS THAT RELATE TO THE STATE BOARD OF DIETETIC PRACTICE.
