- (3) The Office for Children, Youth, and Families.
- f(b) (D) The information and <u>PORTIONS OF</u> records that may be disclosed under this section shall be limited to:
 - (1) Demographic information to enable precise identification of the child;
- (2) A listing of the types, dates, and duration of services provided by the agency; and
- (3) A listing of dates of any evaluations performed by the agency.] THOSE WHICH ARE IDENTIFIED SPECIFICALLY IN THE WRITTEN REQUEST.
- (D) (E) EXCEPT WHERE CONSENT OF THE PERSON IN INTEREST IS NOT REQUIRED BY LAW, INFORMATION AND RECORDS SHALL BE DISCLOSED UNDER SUBSECTION (C) OF THIS SECTION ONLY AFTER WRITTEN CONSENT HAS BEEN OBTAINED FROM THE PERSON IN INTEREST OR OTHER INDIVIDUAL AUTHORIZED TO GIVE CONSENT IN ACCORDANCE WITH SUBSECTION (E) OF THIS SECTION.
- (E) (F) IF THE PERSON IN INTEREST IS NOT REASONABLY AVAILABLE TO GIVE <u>WRITTEN</u> CONSENT, THE FOLLOWING INDIVIDUALS, NOT LISTED IN ORDER OF PRIORITY, MAY CONSENT <u>IN WRITING</u> TO THE RELEASE OF INFORMATION REGARDING A MINOR:
 - (1) AN ADULT WHO HAS CARE AND CONTROL OF THE MINOR;
 - (2) A SPOUSE OF AN ADULT WHO HAS CARE OF THE MINOR;
- (3) A COURT THAT HAS JURISDICTION OVER A SUIT AFFECTING THE PARENT-CHILD RELATIONSHIP OF WHICH THE MINOR IS THE SUBJECT; OR
- (4) (3) FOR MINORS IN ITS CARE AND CUSTODY, THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, THE DEPARTMENT OF JUVENILE SERVICES, OR A LOCAL DEPARTMENT OF SOCIAL SERVICES.
- (F) (G) A PERSON AUTHORIZED TO CONSENT TO THE RELEASE OF INFORMATION UNDER SUBSECTION (E) OF THIS SECTION SHALL:
- (1) CONFIRM IN WRITING THAT THE PERSON IN INTEREST IS NOT REASONABLY AVAILABLE; AND
- (2) INCLUDE THE WRITTEN CONFIRMATION IN THE RECORD FROM WHICH THE INFORMATION IS RELEASED.
- (G) (H) (1) CHILD PROTECTIVE SERVICES RECORDS COLLECTED BEFORE OCTOBER 1, 1993 ARE EXCLUDED FROM THE INFORMATION AND RECORDS THAT MAY BE EXCHANGED IN ACCORDANCE WITH THIS SECTION UNLESS THE PERSON IN INTEREST:
- (I) IS GIVEN THE OPPORTUNITY TO REVIEW THE RECORDS AND THE INFORMATION TO BE EXCHANGED; AND
 - (II) GIVES CONSENT.
