~~(3) WITHIN 10 DAYS OF THE RECEIPT OF A CHANGE OF ADDRESS FORM, THE MOTOR VEHICLE ADMINISTRATION SHALL FORWARD A COPY TO THE APPROPRIATE BOARD TO BE PROCESSED IN ACCORDANCE WITH § 3-9 OF THIS SUBTITLE. IF THE MOTOR VEHICLE ADMINISTRATION ACCEPTS AN APPLICATION, RENEWAL, OR CHANGE OF ADDRESS OR NAME FORM WITHIN 5 DAYS BEFORE A VOTER REGISTRATION DEADLINE, THE MOTOR VEHICLE ADMINISTRATION SHALL FORWARD THE APPLICATION, RENEWAL, OR CHANGE OF ADDRESS OR NAME TO THE APPROPRIATE STATE ELECTION OFFICIAL NO LATER THAN 5 DAYS FROM THE DATE OF ACCEPTANCE.~~

(A) (1) THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS ~~IS RESPONSIBLE FOR DESIGNATING~~ SHALL DESIGNATE PUBLIC AGENCIES AND NONGOVERNMENTAL AGENCIES AS VOTER REGISTRATION AGENCIES WHERE QUALIFIED PERSONS MAY REGISTER TO VOTE.

(2) THE STATE ~~BOARD~~ ADMINISTRATIVE BOARD OF ELECTION LAWS SHALL DESIGNATE THE FOLLOWING OFFICES AS VOTER REGISTRATION AGENCIES:

(I) ALL OFFICES IN THE STATE WHICH PROVIDE PUBLIC ASSISTANCE; AND

(II) ALL OFFICES IN THE STATE THAT PROVIDE STATE-FUNDED PROGRAMS PRIMARILY ENGAGED IN PROVIDING SERVICES TO PERSONS WITH DISABILITIES.

~~(3) THE STATE BOARD SHALL DESIGNATE OTHER STATE AND LOCAL OFFICES THAT ARE FREQUENTED BY THE PUBLIC AS VOTER REGISTRATION AGENCIES.~~

~~(4) SUBJECT TO AGREEMENT WITH FEDERAL AGENCIES AND NONGOVERNMENTAL ENTITIES, THE STATE BOARD MAY DESIGNATE SUCH AGENCIES AND ENTITIES AS VOTER REGISTRATION AGENCIES.~~
