- (3) By July 1 of each year, the Board of Regents shall submit to the Maryland Higher Education Commission, to the Governor and, subject to § 2–1312 of the State Government Article, to the General Assembly an annual review of the plan.
- (N) (M) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE UNIVERSITY SHALL USE THE STATEWIDE FINANCIAL MANAGEMENT INFORMATION SYSTEM ADMINISTERED BY THE DEPARTMENT OF BUDGET AND FISCAL PLANNING AS ITS ACCOUNTING, BUDGETING, PERSONNEL, AND PAYROLL SYSTEM.
- (O) (N) THE LEGISLATIVE AUDITOR SHALL AUDIT ALL EXPENDITURES AND ACCOUNTS OF MORGAN STATE UNIVERSITY IN ACCORDANCE WITH §§ 2–1215 THROUGH 2–1222 OF THE STATE GOVERNMENT ARTICLE.

  - (C) "UNIVERSITY" MEANS MORGAN STATE UNIVERSITY.

## 14-1A-02.

THIS SUBTITLE DOES NOT APPLY TO A MEMBER OF THE FACULTY, AN EXECUTIVE STAFF MEMBER, OR A PROFESSIONAL ADMINISTRATIVE STAFF MEMBER OF THE UNIVERSITY.

## 14-1A-03.

- (A) THE PRESIDENT MAY DELEGATE TO THE OFFICE OF ADMINISTRATIVE HEARINGS THE AUTHORITY TO CONDUCT A HEARING AND ISSUE A PROPOSED DECISION FOR APPROVAL BY THE PRESIDENT SECRETARY OF PERSONNEL IN ANY OF THE FOLLOWING:
- (1) AN APPEAL UNDER § 14-1A-04(B) OF THIS SUBTITLE FROM A REJECTION OF A CLASSIFIED EMPLOYEE DURING PROBATION THAT RESULTS FROM A PROMOTION;
- (2) AN APPEAL UNDER § 14-1A-05 OF THIS SUBTITLE FROM CHARGES FOR REMOVAL OF A CLASSIFIED EMPLOYEE;
- (3) A PRELIMINARY HEARING UNDER § 14–1A–06 OF THIS SUBTITLE ON THE SUSPENSION OF A CLASSIFIED EMPLOYEE PENDING REMOVAL;
- (4) AN APPEAL UNDER § 14-1A-07 OF THIS SUBTITLE FROM THE DISCIPLINARY SUSPENSION OF A CLASSIFIED EMPLOYEE; AND
- (5) AN APPEAL UNDER § 14-1A-08 OF THIS SUBTITLE FROM THE PROPOSED DEMOTION OF A CLASSIFIED EMPLOYEE.
