~~(D) IF THE CONSULTATION INITIATED UNDER SUBSECTION (B) OF THIS SECTION RESULTS IN A DETERMINATION THAT THE CONDITIONS IN THE PLACE OF EMPLOYMENT ARE NOT IN COMPLIANCE WITH THE PROVISIONS OF THIS TITLE, THE CONSULTANT OR OTHER REPRESENTATIVE OF THE COMMISSIONER SHALL ASSIST THE EMPLOYER TO DEVELOP A PLAN FOR ACHIEVING COMPLIANCE WITH THE PROVISIONS OF THIS TITLE.~~

~~(I) SUBMITS AN APPLICATION FOR EXTENSION TO THE COMMISSIONER AT LEAST 30 DAYS BEFORE THE DATE ON WHICH THE PLAN IS TO EXPIRE; AND~~

~~(II) IS UNABLE TO CARRY OUT A PLAN WITHIN ITS TIME REQUIREMENTS BECAUSE:~~
