THE SPECIAL SECRETARY MAY CALL UPON ANY OF THE SUBCABINET MEMBERS TO PROVIDE ADDITIONAL STAFF ASSISTANCE AS NEEDED. THE SPECIAL SECRETARY MAY ESTABLISH COMMITTEES AND TASK FORCES, AS NEEDED, TO CARRY OUT THE WORK OF THE SUBCABINET.~~

~~(A) THE SPECIAL SECRETARY FOR CHILDREN, YOUTH, AND FAMILIES IS APPOINTED BY AND SERVES AT THE PLEASURE OF THE GOVERNOR AND IS DIRECTLY RESPONSIBLE TO THE GOVERNOR. THE SPECIAL SECRETARY SHALL RECEIVE THE SALARY PROVIDED IN THE STATE BUDGET.~~
