(A) IN THIS SECTION, "CODE OFFICIAL" MEANS A PUBLIC OFFICIAL RESPONSIBLE FOR THE REVIEW OF BUILDING PERMIT DOCUMENTS OR THE ISSUANCE OF BUILDING PERMITS.

(B) THE BOARD SHALL:

(1) KEEP A LIST OF THE NAMES AND MAILING ADDRESSES OF ALL LICENSEES;

(2) PROVIDE EACH CODE OFFICIAL WITH A COPY OF THE LIST ANNUALLY; AND

(3) PROVIDE ANY OTHER PERSON WHO MAKES A REQUEST WITH A COPY OF THE LIST AT A REASONABLE FEE SET BY THE BOARD.

(C) (1) THE BOARD SHALL PROVIDE ALL LICENSEES AND CODE OFFICIALS WITH A PERIODIC NEWSLETTER NOT LESS THAN SEMI-ANNUALLY ON THE ACTIVITIES OF THE BOARD.

(2) THE BOARD MAY ~~JOINTLY PUBLISH THE NEWSLETTER~~ PUBLISH THE NEWSLETTER JOINTLY WITH THE STATE BOARD OF PROFESSIONAL ENGINEERS, THE STATE BOARD OF ARCHITECTS, THE STATE BOARD OF CERTIFIED INTERIOR DESIGNERS, OR ANY COMBINATION OF THESE BOARDS.
