SECTION 2. AND BE IT FURTHER ENACTED, That on the effective date of this Act, the State Board of Architects, the State Board of Professional Engineers, the State Board of Certified Interior Designers, and the State Board of Examiners of Landscape Architects shall distribute to each current licensee or certificate holder a copy of each Board's respective Act and the rules and regulations adopted by each Board.

SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 1994.
