~~(B) (1) A CARRIER THAT ELECTS NOT TO RENEW HEALTH BENEFIT PLANS OFFERED IN A PARTICULAR REGIONAL AREA THROUGH A REGIONAL HEALTH COOPERATIVE SHALL:~~

~~(I) PROVIDE ADVANCE NOTICE OF ITS DECISION UNDER THIS PARAGRAPH TO THE AFFECTED REGIONAL HEALTH COOPERATIVE AND THE INSURANCE COMMISSIONER; AND~~

~~(II) PROVIDE NOTICE OF THE DECISION TO ENROLLEES AT LEAST 120 DAYS PRIOR TO THE NONRENEWAL OF ANY HEALTH BENEFIT PLAN BY THE CARRIER.~~

~~(2) THE PARTICIPATING CARRIER SHALL BE PROHIBITED FROM WRITING NEW BUSINESS WITH THAT REGIONAL HEALTH COOPERATIVE FOR A PERIOD OF 5 YEARS FROM THE DATE OF NOTICE TO THE REGIONAL HEALTH COOPERATIVE OR UNTIL THE REGIONAL HEALTH COOPERATIVE INVITES THE CARRIER TO RENEW PARTICIPATION, WHICHEVER IS SOONER.~~

~~(3) IN A PARTICULAR REGIONAL AREA, A CARRIER MAY NOT RENEW HEALTH BENEFIT PLANS THAT ARE OFFERED OUTSIDE THE REGIONAL HEALTH COOPERATIVE IF THE CARRIER ELECTS NOT TO RENEW HEALTH BENEFIT PLANS OFFERED THROUGH THE REGIONAL HEALTH COOPERATIVE.~~
