RESOLUTION OF THE BOARD OF TOWN COMMISSIONERS TO AMEND ARTICLE 2 OF THE CHARTER OF THE TOWN OF BEL AIR TO EXTEND THE CORPORATE BOUNDARIES AND TO DESIGNATE THE ZONING CLASSIFICATION OF THE LAND BEING ANNEXED

A Resolution of the Board of Town Commissioners, adopted pursuant to the authority of Article 11-2 of the Constitution of Maryland, Section 19 of Article 23A of the Annotated Code of Maryland, 1957 (1990 Replacement Volume), entitled "Corporations - Municipal", subheading "Annexation", to enlarge the corporate boundaries of the Town of Bel Air by amending the Public Local Law of Harford County, being a part of Article 13 of the Code of Public Local Laws of Maryland by adding to Section 202 entitled Additions, paragraph "u", to Article II CORPORATE LIMITS of the Charter of the Town of Bel Air, annexing to said corporate boundaries the following area, contiguous to and adjoining the present corporate boundaries of the Town of Bel Air, on the south side of Churchville Road, (hereinafter, "the Property") being two separate parcels of land owned by the Town of Bel Air and the State Highway Administration, respectively (the "Property Owner's") (48.76 acres of land, more or less).
