## , Emergency Bill No. 8-92

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS ARTICLE V, CHAPTER 1, CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY (1984 EDITION, BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY", SUBTITLE "ADMINISTRATION", PROVIDING FOR AN ECONOMIC AND TOURISM DIRECTOR AND GENERALLY PROVIDING FOR THE DUTIES OF THE DIRECTOR AND CHANGING THE EXISTING ECONOMIC DEVELOPMENT ADVISORY BOARD TO AN ECONOMIC AND TOURISM DEVELOPMENT ADVISORY BOARD CONSISTING OF SEVEN (7) MEMBERS AND PROVIDING FOR THE DUTIES OF THE DIRECTOR AND THE BOARD AND THE TERMS OF OFFICE FOR THE ADVISORY BOARD.

## Emergency Bill No. 9-92

AN ACT TO ADD NEW ARTICLE X TO CHAPTER 6 OF THE PUBLIC LOCAL LAWS OF KENT COUNT (1984 EDITION, BEING ARTICLE 15 OF THE PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY", SUBTITLE "LAND USE" ENTITLED "FOREST CONSERVATION ORDINANCE" TO FOLLOW IMMEDIATELY AFTER ARTICLE IX THEREOF ESTABLISHING REQUIREMENTS AND PROCEDURES TO CONSERVE EXISTING FORESTS AND TO PROMOTE REFORESTATION.

## Emergency Bill No. 4-93

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, SECTION 3.48 OF ARTICLE VII, AND SECTION 2.160 OF ARTICLE X OF THE KENT COUNTY ZONING ORDINANCE, CHANGING THE IDENTITY OF THE APPROVAL AUTHORITY FROM THE DEPARTMENT OF MENTAL HEALTH AND HYGIENE TO THE MARYLAND DEPARTMENT OF THE ENVIRONMENT AND CLARIFYING THE DEFINITION OF SEWAGE SLUDGE.
