**Emergency Bill No. 6-93**

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, SECTION 2-1 THROUGH SECTION 2-11, OF ARTICLE I, ENTITLED "DOG CONTROL ORDINANCE", CHAPTER 2, CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY (BEING ARTICLE 15 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY" SUBTITLE "ANIMALS" CHANGING THE TITLE OF ARTICLE I TO "KENT COUNTY DOG CONTROL AND ANIMAL CRUELTY ORDINANCE", EFFECTING STYLISTIC CHANGES, STRENGTHENING ENFORCEMENT PROCEDURES, CHANGING THE PENALTY FOR VIOLATIONS TO MUNICIPAL INFRACTIONS, ENABLING THE COUNTY COMMISSIONERS TO ESTABLISH FEES AND GENERALLY FORTIFYING THE OLD ORDINANCE.

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, SECTION 7-1 IN ITS ENTIRETY, OF ARTICLE I, PARKS AND RECREATION, CHAPTER 7 OF THE PUBLIC LOCAL LAWS OF KENT COUNTY (BEING ARTICLE 15 OF THE CODE OF LOCAL LAWS OF MARYLAND) TITLE "KENT COUNTY" SUBTITLE "RECREATION" TO CHANGE THE FUNCTION OF THE BOARD OF PARKS AND RECREATION TO AN ADVISORY ROLE TO THE COUNTY COMMISSIONERS OF KENT COUNTY.

AN ACT CONCERNING

**Repeal and Re-enactment with Amendments of Section 13-104 of Title 13 of the Code of Public Local Laws of Queen Anne's County (Article 18 of the Code of Public Local Laws of Maryland).**

FOR the purpose of eliminating the position of County Roads Engineer, deleting the authorization and directive to employ a clerk, deputy clerk and attorney to the County Roads Board and generally eliminating provisions as to Roads Engineer, clerk, deputy clerk and attorney to the County Roads Board.

BY repealing and re-enacting, with amendments the Public Local Laws of Queen Anne's County, Section 13-104 of Article 18 of the Public Local Laws of Maryland
