22-304. SAME — PURCHASE OF SERVICE CREDIT AT MEMBER'S COST.

## (A) IN GENERAL.

A MEMBER MAY PURCHASE SERVICE CREDIT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION FOR PERIODS OF EMPLOYMENT DESCRIBED IN SUBSECTION (C) OR (D) OF THIS SECTION FOR WHICH THE MEMBER IS NOT OTHERWISE ENTITLED TO SERVICE CREDIT.

- (B) PAYMENT FOR SERVICE CREDIT.
- (1) A MEMBER WHO PURCHASES SERVICE CREDIT UNDER THIS SECTION SHALL:
- (I) COMPLETE A CLAIM FOR THE SERVICE CREDIT AND FILE IT WITH THE BOARD OF TRUSTEES ON A FORM THAT THE BOARD OF TRUSTEES PROVIDES: AND
- (II) PAY TO THE BOARD OF TRUSTEES IN A SINGLE PAYMENT THE MEMBER CONTRIBUTIONS THE MEMBER WOULD HAVE MADE FOR THE PERIOD OF EMPLOYMENT FOR WHICH SERVICE CREDIT IS BEING PURCHASED PLUS REGULAR INTEREST TO THE DATE OF PAYMENT.
- (2) A MEMBER MAY PAY FOR SERVICE CREDIT PURCHASED UNDER THIS SECTION AT ANY TIME BEFORE RETIREMENT.
- (C) TYPES OF SERVICE CREDIT MEMBERS OF THE EMPLOYEES' RETIREMENT SYSTEM.
- (1) A MEMBER OF THE EMPLOYEES' RETIREMENT SYSTEM MAY PURCHASE SERVICE CREDIT FOR A PERIOD OF EMPLOYMENT:
- (I) FROM JULY 1, 1970, TO JUNE 30, 1972, BOTH INCLUSIVE, DURING WHICH A MEMBER ELECTED TO DELAY ENROLLMENT IN THE EMPLOYEES' RETIREMENT SYSTEM;
- (II) FROM JANUARY 1, 1972, TO JULY 1, 1975, BOTH INCLUSIVE, FOR WHICH A MEMBER HAS BEEN EMPLOYED BY A BOARD OF SUPERVISORS OF ELECTIONS:
- (III) AS STAFF FOR THE COMMISSION TO REVISE THE ANNOTATED CODE;
- (IV) BY THE DIVISION OF EMPLOYMENT SERVICE WHEN IT WAS UNDER FEDERAL CONTROL;
