(2) IF A MEMBER IS UNABLE TO APPLY, THE MEMBER'S STATE OR COUNTY SUPERINTENDENT MAY COMPLETE AND SUBMIT AN APPLICATION TO THE BOARD OF TRUSTEES FOR THE MEMBER.

29-104. SAME — LIMITATIONS ON FILING FOR DISABILITY.

(A) IN GENERAL.

EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION AND SUBJECT TO SUBSECTION (D) OF THIS SECTION, AN APPLICATION FOR DISABILITY RETIREMENT MUST BE SUBMITTED BEFORE THE DATE MEMBERSHIP ENDS.

(B) EXCEPTION — EXTENSION OF MEMBERSHIP.

(1) THIS SUBSECTION APPLIES ONLY TO:

(I) AN APPLICATION FOR AN ORDINARY OR ACCIDENTAL DISABILITY RETIREMENT ALLOWANCE UNDER THE EMPLOYEES' PENSION SYSTEM OR THE TEACHERS' PENSION SYSTEM; OR

(II) AN APPLICATION FOR AN ACCIDENTAL DISABILITY RETIREMENT ALLOWANCE UNDER THE LOCAL FIRE AND POLICE SYSTEM.
