(B) CONSUMER PRICE INDEX.

"CONSUMER PRICE INDEX" MEANS THE CONSUMER PRICE INDEX (ALL URBAN CONSUMERS — UNITED STATES CITY AVERAGE — ALL ITEMS) AS OF DECEMBER 31 AS PUBLISHED BY THE UNITED STATES DEPARTMENT OF LABOR, BUREAU OF LABOR STATISTICS.

(C) INITIAL ALLOWANCE.

"INITIAL ALLOWANCE" MEANS A BASIC ALLOWANCE OR THE ALLOWANCE ELECTED UNDER §§ 21-402 AND 21-403 OF THIS ARTICLE.
