of the County and state aforesaid at and before the sealing and delivery hereof  
the receipt whereof we do hereby acknowledge, have granted, bargained and  
sold, and by these presents do grant, bargain and sell unto the said Al-  
gernon Thomas, his executors, administrators and assigns two grey Horses  
named Bell and Travler, one pair of white Oxen and one Yoke, two Cows  
and calves, one white Cow, three Heifers Ears marked with two underbits  
one Buffalo ox, one Bull yearling, twelve head of Hogs, two Carts, two  
feather Beds and Bedsteads, one Mantle Clock, one Cupboard and contents,  
one dozen Chairs, two Tables, four Chests, one lot of hollow ware or  
Castings, one lot of Wood ware, one lot of ploughs and Harrows and  
gear, one crop of wheat and Corn growing now at home, one crop of Corn  
now growing on Mr. W. N. M. Edmondson's farm &c. all of which property is  
now in my possession. To have and to hold the same described property a-  
bove bargained and sold to the said Algernon Thomas his executors,
