To have and to hold the said above described Negroes unto the said Henry Bibby his heirs & assigns to his and their sole use and use forever: Provided Never theless, and it is the true intent and meaning of these presents, and of the said parties herunto, that if the said Isaac H. Andrews shall save the said Henry Bibby harmless from all liability on account of the said Bibby's Suretyship for the said Andrews on a note due to John A. Scott administrator of Hugh Wingate for the purchase of a Vessel, and also save the said Bibby harmless from all liability on account of all other Suretyships for the said Andrews; then and in such case these presents and every matter and thing herein contained shall be of no effect.
