From all men by these presents that I Samuel G. Fleckarty of Donchester County in the State of Maryland, for and in consideration of the sum of Seventy Eight Dollars and seventy four Cents Current Money to me in hand paid by Samuel Griffin of Donchester County in the State of Maryland, before the sealing and delivery of these presents, the receipt whereof of the said Samuel G. Fleckarty do hereby Acknowledge have granted, bargained and sold, and by these presents do grant bargain and sell unto the said Samuel Griffin his executors Administrators and Assigns all my right to the Crop of Corn on the Farm where I now live supposed to be eight barrels and also of my right to the blade and top Fodder on the said Farm and also and singular the said Corn and Fodder which is now in my possession — To Have and to Hold all and singular the said Corn and fodder and also the premises above bargained and sold or mentioned and intended to be to the said Samuel Griffin his executors Administrators and Assigns forever, and the said Samuel G. Fleckarty for myself my heirs executors and Administrators all and singular the said Corn and Fodder and all other the premises unto the said Samuel Griffin his executors Administrators and Assigns against me the said Samuel G. Fleckarty my executors and Administrators and against all and every person or persons whatsoever shall and well warrant and forever defend by these presents of all and singular which said Corn and fodder and also the premises of the said Samuel G. Fleckarty have put the said Samuel Griffin in full possession by delivering to him the said Samuel Griffin one ear of corn at the sealing and delivery of these presents in the name of the whole premises hereby bargained and sold or mentioned or intended to be to unto him the said Samuel Griffin as aforesaid — In Testimony Whereof I have hereunto set my hand and affix my seal this 31st day of August 1844
