 Daniel J. Riggs } Know all men by these presents that I Daniel J. Riggs of Dor-
 Chester County in the State of Maryland, for and in consideration
 of the sum of Forty dollars, current money, to me in hand paid by Sary Wright
 of Dorchester County in the said State, at and before the sealing & delivering of
 these presents, the receipt whereof I the said Daniel J. Riggs do hereby acknowledge,
 have granted, bargained and sold, and by these presents do grant, bargain
 and sell unto the said Sary Wright, her executors, administrators and assigns,
 all the goods, house-hold stuff, implements and furniture particularly mentioned,
 expressed and contained, hereinafter particularly mentioned, that is to say,
 one Bed, Bedstead and furniture, one set of Chairs, one Carpet, one Stove, one
 Iron pot, one Dutch oven, Crockery and earthen ware, one pine Table, Knives
 and forks, and all the balance of my house hold and kitchen furniture,
 all and singular which said goods and chattels are now remaining,
 standing and being in a certain Messuage or tenement situate in
 Cambridge, and now in the occupation of the said Sary Wright - To
 have and to hold all and singular the said goods, house-hold stuff &
 furniture, and other premises above bargained and sold, or mentioned
 and intended so to be, to the said Sary Wright, her Executors, administrators
 and assigns forever - And I the said Daniel J. Riggs, for myself, my
 heirs, executors and administrators, all and singular the said goods, house-
 hold stuff and furniture and other the premises, unto the said
 Sary Wright, her Executors, administrators and assigns, against me
 the said Daniel J. Riggs, my Executors and administrators, and against
 all and every other person or persons whatsoever shall and will adventure
 and forever defend by these presents - of all and singular which said goods
 house-hold stuff and furniture and other premises, I the said Daniel J.
 Riggs have put the said Sary Wright in full possession by delivering to
 her, the said Sarah Wright, all of the above named articles at the
 sealing and delivering of these presents in the name of the whole prem-
 ises hereby bargained and sold, or mentioned and intended to be so, unto
 her the said Sary Wright as aforesaid. In Witness whereof I have here-
 unto set my hand and seal this 7th day of May 1845.
