To have and to hold all and singular the said property above bargained and sold, or mentioned and intended so to be to the said Richard Rhodes, his Executors, Administrators and assigns forever - And we the said Sylvester H. Rhodes and Benjamin W. Rhodes, for ourselves, our heirs, Executors and Administrators, all and singular the above mentioned property unto the said Richard Rhodes, his heirs, executors, administrators and assigns, we the said Sylvester H. Rhodes & Benjamin W.
