 John Brown, do hereby acknowledge, have granted, bargained & sold,  
 unto the said Sarah Woolford, her heirs, executors & administrators,  
 one Horse, one Yoke Ox, 2 yearlings, 4 Dogs, one Ox Cart, 2 ploughs,  
 1 Harrow, 1 Crubbing Maw, 1 Wending Maw, 2 Beds, Bedssteads & furniture,  
 4 Barrels Corn, one Crop of wheat now growing and now in my possession.  
 To have and to hold the above described Household stuff & farming  
 implements to the said Sarah Woolford, her Executors, Administrators and  
 Assigns forever. And I the said John Brown, for myself, my heirs,  
 Executors & Administrators, the aforesaid Horse, Ox, yearlings &c to the  
 said Sarah Woolford, her Executors, Administrators & Assigns, against  
 me, the said John Brown, my Executors & Administrators, and against  
 all and every person or persons whomsoever shall & will warrant to  
 former depend by these presents: Provided nevertheless that in case  
 the said John Brown, ~~my Executors & Administrators~~ shall pay,  
 and satisfy to the said Sarah Woolford, or to her Executors, Admin-  
 istrators or Assigns the sum of one hundred & sixteen dollars,  
 current money, with interest for the same, on or before the first day  
 of January next ensuing, then this Bill of sale & every matter &
