A SPECIAL RESTRICTED CERTIFICATE OF QUALIFICATION ISSUED UNDER THIS SECTION AUTHORIZES THE HOLDER TO ACT AS AN AGENT ONLY AS TO TRAVEL TICKET POLICIES OF LIFE INSURANCE, ACCIDENT INSURANCE, OR BAGGAGE INSURANCE ON PERSONAL EFFECTS.

(C) APPLICATION AND RENEWAL FORMS.

THE COMMISSIONER MAY REQUIRE AND PROVIDE SPECIAL FORMS REQUIRING INFORMATION THE COMMISSIONER CONSIDERS PROPER IN CONNECTION WITH THE APPLICATION FOR OR RENEWAL OF SPECIAL RESTRICTED CERTIFICATES OF OUALIFICATION ISSUED UNDER THIS SECTION.

10-123. SAME — VENDING MACHINES IN TERMINAL FACILITIES OF COMMON CARRIERS.

(A) IN GENERAL.

- (1) AN AGENT THAT HOLDS A CERTIFICATE OF QUALIFICATION MAY SOLICIT APPLICATIONS FOR AND ISSUE POLICIES OF PERSONAL TRAVEL INSURANCE, LIFE INSURANCE, ACCIDENT INSURANCE, OR BAGGAGE INSURANCE BY VENDING MACHINES THAT ARE SUPERVISED BY THE AGENT AND LOCATED ONLY IN TERMINAL FACILITIES OF COMMON CARRIERS.
- (2) THE COMMISSIONER SHALL ISSUE TO THE AGENT A SPECIAL VENDING MACHINE LICENSE FOR EACH VENDING MACHINE USED AS DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION.
 - (B) CONTENTS OF LICENSE.

THE VENDING MACHINE LICENSE SHALL STATE:

- (1) THE NAME AND ADDRESS OF THE INSURER AND AGENT:
- (2) THE NAME OF THE POLICY TO BE SOLD;
- (3) THE SERIAL NUMBER OF THE MACHINE; AND
- (4) THE PLACE WHERE THE MACHINE WILL OPERATE.
- (C) DISPLAY OF LICENSE.

NOTICE OF A VENDING MACHINE LICENSE SHALL BE DISPLAYED:

(1) ON OR ABOVE EACH VENDING MACHINE IN USE; AND
