- (B) THE FORVM SHALL INCLUDE:
  - (1) THE GOVERNOR OR THE GOVERNOR'S DESIGNEE;
- (2) AS NONVOTING MEMBERS, THREE MEMBERS OF THE MARYLAND STATE SENATE, APPOINTED BY THE PRESIDENT OF THE SENATE, ONE EACH FROM THE THREE RURAL REGIONS OF THE STATE;
- (3) AS NONVOTING MEMBERS, THREE MEMBERS OF THE MARYLAND HOUSE OF DELEGATES, APPOINTED BY THE SPEAKER OF THE HOUSE OF DELEGATES. ONE EACH FROM THE THREE RURAL REGIONS OF THE STATE:
  - (4) AS DETERMINED UNDER THE BYLAWS OF THE FORVM:
- (I) REPRESENTATIVES FROM FEDERAL AGENCIES THAT SERVE RURAL INTERESTS; AND
- (II) REPRESENTATIVES FROM PRIVATE SECTOR ORGANIZATIONS, INCLUDING RURAL-BASED FOR-PROFIT AND NONPROFIT ORGANIZATIONS AND RURAL CLIENT GROUPS; AND
- (5) ANY OTHER INDIVIDUAL WHO ELECTS TO JOIN THE FORVM AND WHO QUALIFIES UNDER SUBSECTION (A) OF THIS SECTION.

  15–104.
- (A) FROM AMONG ITS MEMBERS, THE FORVM ANNUALLY SHALL ELECT A CHAIRMAN.
- (B) THE FORVM SHALL ADOPT BYLAWS TO REGULATE ITS AFFAIRS AND THE ORDERLY CONDUCT OF ITS BUSINESS.
  - (C) (1) THE FORVM SHALL ESTABLISH AN EXECUTIVE BOARD.
    - (2) THE EXECUTIVE BOARD SHALL INCLUDE:
- (I) THE CHAIRMAN OF THE FORVM, WHO SHALL SERVE AS CHAIRMAN OF THE EXECUTIVE BOARD:
  - (II) THE GOVERNOR OR THE GOVERNOR'S DESIGNEE:
- (III) TWO REPRESENTATIVES OF THE MARYLAND MUNICIPAL LEAGUE, SELECTED FROM RURAL REGIONS OF THE STATE;
- (IV) TWO REPRESENTATIVES OF THE MARYLAND ASSOCIATION OF COUNTIES, SELECTED FROM RURAL REGIONS OF THE STATE;
  - (V) ONE REPRESENTATIVE OF A FEDERAL AGENCY:
- (VI) ONE REPRESENTATIVE OF THE DELMARVA ADVISORY COUNCIL;
- (VII) ONE REPRESENTATIVE OF THE TRI-COUNTY COUNCIL FOR SOUTHERN MARYLAND;
