(E) (1) THE PERSON WHO REMOVES A VESSEL FROM A MARINA SHALL IMMEDIATELY DELIVER THE VESSEL DIRECTLY TO A LOCATION CUSTOMARILY USED BY THE PERSON.

(2) THE PERSON WHO EXERCISES CONTROL OVER THE VESSEL AT THE LOCATION TO WHICH THE VESSEL IS DELIVERED AFTER REMOVAL FROM A MARINA SHALL PROVIDE THE VESSEL OWNER OR THE VESSEL OWNER'S AGENT IMMEDIATE AND CONTINUOUS OPPORTUNITY TO RETAKE POSSESSION OF THE VESSEL.

~~(E) (F) ANY PERSON WHO UNDERTAKES THE REMOVAL OF~~ REMOVES A VESSEL FROM A MARINA IN VIOLATION OF ANY PROVISION OF THIS SECTION:

(1) SHALL BE LIABLE FOR ACTUAL DAMAGES SUSTAINED BY ANY PERSON THE VESSEL OWNER OR THE VESSEL OWNER'S AGENT AS A RESULT OF THE VIOLATION; AND

(2) SHALL BE LIABLE TO THE VESSEL OWNER OR THE VESSEL OWNER'S AGENT FOR UP TO TRIPLE THE AMOUNT PAID BY THE OWNER OR THE OWNER'S AGENT TO RETAKE POSSESSION OF THE VESSEL, AS THE COURT MAY DETERMINE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be construed or applied to require the Department of Natural Resources to remove any vessel under the provisions of this Act, or to abrogate the provisions of § 8-721 of the Natural Resources Article.

SECTION 2: 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1995.

AN ACT concerning

Creation of a State Debt - Cecil County - The Town of North East - Community Park
