SECTION ~~4.~~ 3. AND BE IT FURTHER ENACTED, That before Section 1; or Section 2, ~~or Section 3~~ of this Act becomes effective, each of these Sections shall first be submitted to a special referendum of the legally qualified voters of Calvert County to be held on ~~September 5~~ November 7, 1995. The cost of the referendum, if any, shall be paid by the Calvert County Board of County Commissioners. The Calvert County Board of County Commissioners and the Calvert County Board of Supervisors of Elections shall do those things necessary and proper to provide for and hold the referendum required by this section. There shall be printed on the ballots or ballot labels to be used at this election the title of this Act and underneath the title, on separate lines, a square or box to the right of and opposite the words: "For a School Board Appointed by the County Commissioners (Section 1 of this Act)"; and a corresponding square or box to the right of and opposite the words "For a School Board Elected by the Voters of Calvert County
