(2) ONCE AN INDIVIDUAL IS FOUND OUT OF TO BE NOT IN COMPLIANCE, THE SOCIAL SERVICES CASEWORKER SHALL INVESTIGATE THE REASONS FOR THE NONCOMPLIANCE AND PROVIDE ASSISTANCE.

(3) (I) FOR THE FIRST CUMULATIVE 6 MONTHS OF NONCOMPLIANCE, THE INDIVIDUAL NOT IN COMPLIANCE SHALL BE REMOVED FROM THE CALCULATION OF AFDC BENEFITS UNTIL THE INDIVIDUAL IS IN COMPLIANCE.

(II) IF AFTER A TOTAL OF 6 MONTHS THE INDIVIDUAL IS STILL NOT IN COMPLIANCE, THE AFDC CASE SHALL BE CLOSED AND THE FAMILY SHALL BE INELIGIBLE FOR FUTURE AFDC BENEFITS UNLESS THE INDIVIDUAL:

1. REAPPLIES FOR AFDC BENEFITS; AND
2. COMPLIES WITH THE REQUIREMENTS OF THE PILOT FOR 30 DAYS PRIOR TO RECEIVING AFDC BENEFITS.

~~(3) IN THE SECOND INSTANCE OF NONCOMPLIANCE, THE FOLLOWING SANCTIONS SHALL BE IMPOSED:~~

~~(I) ALL AFDC BENEFITS FOR THE FAMILY SHALL BE TERMINATED, BUT THE CASE SHALL BE IN AN ACTIVE NO PAY STATUS AND, IF THE INDIVIDUAL COMPLIES WITHIN THE NEXT 3 MONTHS, AFDC BENEFITS FOR THE FAMILY SHALL BE RESUMED; AND~~

~~(II) IF AFTER 3 MONTHS THE INDIVIDUAL IS STILL NOT IN COMPLIANCE, THE CASE SHALL BE CLOSED AND THE FAMILY SHALL BE INELIGIBLE FOR FUTURE AFDC BENEFITS UNLESS THE INDIVIDUAL:~~
