SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

Article - Health - General

SUBTITLE 3. MISCELLANEOUS PROVISIONS.

1-301.

(A) THE HEALTH RESOURCES PLANNING COMMISSION, THE HEALTH SERVICES COST REVIEW COMMISSION, AND THE HEALTH CARE ACCESS AND COST COMMISSION SHALL EACH COORDINATE ITS ACTIVITIES AND DUTIES WITH THE OTHER COMMISSIONS IN THE FOLLOWING MANNER:

(1) CONDUCTING MEETINGS ON AT LEAST A QUARTERLY BASIS BETWEEN THE CHAIRMEN AND EXECUTIVE DIRECTORS OF EACH COMMISSION TO DISCUSS ISSUES FACING THE COMMISSIONS AND TO DETERMINE METHODS FOR EACH COMMISSION TO BETTER COORDINATE THE ACTIVITIES AND DUTIES OF THE COMMISSIONS;

(2) CONDUCTING FREQUENT MEETINGS BETWEEN THE STAFF MEMBERS OF EACH COMMISSION TO DISCUSS ISSUES FACING THE COMMISSIONS AND TO FACILITATE THE COORDINATION OF THE ACTIVITIES AND DUTIES OF THE COMMISSIONS;

(3) SHARING COPIES OF ALL PUBLIC REPORTS, MINUTES FROM PUBLIC MEETINGS OR HEARINGS, AND ANY DOCUMENTS OR LETTERS THAT MAY BE USEFUL TO ONE OR MORE OF THE COMMISSIONS; AND
