- 2. "CASINO NIGHT" DOES NOT INCLUDE A BENEFIT PERFORMANCE SUCH AS A CARNIVAL, FAIR, OR BAZAAR AT WHICH THE ONLY FORM OF GAMING IS A WHEEL OF FORTUNE, BIG WHEEL, OR OTHER WHEEL OF CHANCE.
- (III) "COUNTY" MEANS THE GOVERNING BODY OF PRINCE GEORGE'S COUNTY OR ITS DESIGNEE.
- (2) THIS SUBSECTION DOES NOT APPLY TO A PERSON, GROUP, OR ORGANIZATION THAT HAS NOT OPERATED MORE THAN FIVE CASINO NIGHTS PER YEAR IN THE CURRENT CALENDAR YEAR OR ANY PREVIOUS CALENDAR YEAR.
- (3) (2) (I) THE COUNTY MAY ISSUE WRITTEN PERMITS FOR THE OPERATION OF CASINO NIGHTS.
- (II) THE COUNTY SHALL ESTABLISH THE \overline{FEE} FOR A PERMIT TO OPERATE A CASINO NIGHT.
- (III) THE FEE FEES ESTABLISHED UNDER SUBPARAGRAPH (II) OF THIS PARAGRAPH SHALL BE SUFFICIENT TO PAY FOR THE COSTS OF ADMINISTERING THIS SUBSECTION, INCLUDING THE REIMBURSEMENT OF EXPENSES OF EACH MEMBER OF THE CASINO NIGHT COMMISSION UNDER PARAGRAPH (5)(III)9B OF THIS SUBSECTION.
- (IV) IN ADDITION TO THE FEE FEES ESTABLISHED UNDER SUBPARAGRAPH (III) OF THIS PARAGRAPH, THE COUNTY MAY SHALL ESTABLISH A LEVY OF UP TO 15 20 PERCENT OF THE GROSS RECEIPTS DERIVED FROM GAMING ACTIVITIES CONDUCTED AT A CASINO NIGHT TO BE EXPENDED FOR GENERAL PURPOSES.
- (4) (3) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A PERSON, GROUP, OR ORGANIZATION MAY NOT CONDUCT A CASINO NIGHT WITHOUT FIRST OBTAINING A PERMIT UNDER PARAGRAPH (2) (3) (2) OF THIS SUBSECTION.
- (5) (4) (1) The [governing body of Prince George's] County may SHALL restrict, regulate, or prohibit the issuance of written permits authorized under this section, INCLUDING A PERMIT FOR A CASINO NIGHT ISSUED UNDER PARAGRAPH (2) OF THIS SUBSECTION.
- (II) NOTWITHSTANDING SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE GOVERNING BODY OF THE COUNTY MAY ESTABLISH A CASINO NIGHT COMMISSION TO RECOMMEND REGULATIONS CONCERNING THE OPERATION OF CASINO NIGHTS, INCLUDING THE RECEIPT OF GRATUITIES BY INDIVIDUALS WHO ASSIST IN THE CASINO NIGHT.
- (III) 1. THE CASINO NIGHT COMMISSION CONSISTS OF NINE MEMBERS.
- 2. EACH OF THE NINE MEMBERS SHALL REPRESENT A DIFFERENT COUNCILMANIC DISTRICT OF PRINCE GEORGE'S COUNTY.
