

(II) A GAMING STICKER MAY BE IN THE FORM OF A BAR CODE OR OTHER FORM THAT THE BOARD DESIGNATES.

(8) "TIP JAR" MEANS A GAMING DEVICE FROM WHICH A NUMBER OR SERIES OF NUMBERS OR OTHER SYMBOL IS OBTAINED FOR CONSIDERATION BY SELECTION OF A SEALED PIECE OF PAPER THAT MAY ENTITLE THE PURCHASER OF THE NUMBER OR NUMBERS OR OTHER SYMBOL TO A PAYOFF IN CASH OR OTHER MANNER IMMEDIATELY UPON RECEIPT OR AS A RESULT OF A SUBSEQUENT ANNOUNCEMENT OF A WINNING NUMBER OR NUMBERS OR OTHER SYMBOL OR ANY OTHER DEVICE COMMONLY RECOGNIZED AS A TIP JAR.

(9) "TIP JAR PACKET" MEANS A PACKAGE CONTAINING TIPS TO BE SOLD BY WAY OF A TIP JAR SUFFICIENT FOR A SINGLE TIP JAR GAME.

~~(6)~~ ~~(9)~~ (10) "TIP JAR LICENSE" MEANS A LICENSE ISSUED BY THE COMMISSION COUNTY AGENCY TO OPERATE A TIP JAR IN THE COUNTY.

~~(7) "GAMING STICKER" MEANS A STICKER ISSUED BY THE COMMISSION THAT IS REQUIRED TO BE AFFIXED TO A TIP JAR BEFORE THE TIP JAR IS SOLD.~~

~~(8)~~ ~~(10)~~ (11) "WHOLESALE'S LICENSE" MEANS A LICENSE ISSUED BY THE COMMISSION COUNTY AGENCY TO SELL TIP JARS JAR PACKETS IN THE COUNTY.

(B) THERE IS A WASHINGTON COUNTY GAMING COMMISSION.

(C) (1) THE COMMISSION CONSISTS OF FIVE MEMBERS APPOINTED ~~BY THE BOARD~~ AS FOLLOWS:

(I) THREE MEMBERS APPOINTED BY THE BOARD;

(II) ONE MEMBER APPOINTED BY THE CHAIRMAN OF THE WASHINGTON COUNTY HOUSE OF DELEGATES DELEGATION, WITH THE CONCURRENCE OF THE COUNTY'S HOUSE DELEGATION; AND

(III) ONE MEMBER APPOINTED BY THE STATE SENATORS WHOSE DISTRICTS ARE WITHIN OR INCLUDE PART OF WASHINGTON COUNTY.

(2) A MEMBER OF THE COMMISSION MAY NOT:

(I) HOLD A TIP JAR LICENSE OR A WHOLESALE'S LICENSE; OR

(II) BE EMPLOYED BY A PERSON WHO HOLDS A TIP JAR LICENSE OR A WHOLESALE'S LICENSE.

(3) A MEMBER OF THE COMMISSION SHALL BE A RESIDENT OF WASHINGTON COUNTY.

(4) THE TERM OF A MEMBER OF THE COMMISSION IS 3 2 YEARS AND BEGINS ON ~~OCTOBER~~ JULY 1.

~~(3)~~ (5) A MEMBER OF THE COMMISSION MAY NOT SERVE MULTIPLE CONSECUTIVE TERMS BE REAPPOINTED WITHIN 5 YEARS AFTER COMPLETION OF A FULL 2-YEAR TERM.
