- (2) (I) THE BOARD MAY AUDIT ANY RECORDS RELATING TO TIP JARS OF A HOLDER OF A TIP JAR LICENSE OR WHOLESALER'S LICENSE.
- (II) A HOLDER OF A TIP JAR LICENSE OR WHOLESALER'S LICENSE SHALL MAKE AVAILABLE TO AN AUDITOR DESIGNATED BY THE BOARD ANY RECORDS REQUIRED FOR AN AUDIT IN ACCORDANCE WITH REGULATIONS OF THE BOARD.
- (III) THE BOARD SHALL MAKE AUDIT REPORTS COMPLETED UNDER THIS PARAGRAPH AVAILABLE FOR PUBLIC INSPECTION.
- (3) A HOLDER OF A TIP JAR LICENSE OR WHOLESALER'S LICENSE SHALL RETAIN ALL RECORDS REQUIRED UNDER REGULATIONS OF THE BOARD FOR AT LEAST 5 YEARS.
  - (L) (K) A PERSON MAY SELL A TIP JAR DEVICE PACKET IN THE COUNTY IF-
    - (1) THE PERSON:

- (II) (2) HAS NOT BEEN CONVICTED OF A VIOLATION OF FELONY OR MISDEMEANOR INVOLVING ANY GAMBLING OR GAMING LAW OF THE STATE, EXCEPT A MISDEMEANOR IN REGARD TO THE OPERATION OF A TIP JAR BEFORE OCTOBER 1, 1995;
  - (HH) (3) IS OF GOOD MORAL CHARACTER;
- (<del>IV)</del> (4) <u>UNLESS ALLOWED UNDER SUBSECTION (<del>P)</del> (O) OF THIS</u> SECTION, DOES NOT HOLD A TIP JAR LICENSE; <del>AND</del>
- $\frac{(V)}{(S)}$  DOES NOT OWE TAXES TO THE COUNTY  $\underbrace{OR\ A\ MUNICIPAL}_{CORPORATION\ IN\ THE\ COUNTY}_{}$ ; AND
- (2) THE PERSON (6) HAS A WHOLESALER'S LICENSE ISSUED BY THE COMMISSION COUNTY AGENCY.
- (M) (L) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE COMMISSION COUNTY AGENCY SHALL MAY ISSUE A WHOLESALER'S LICENSE TO EACH QUALIFIED APPLICANT THAT PAYS THE COMMISSIONER COUNTY AGENCY A FEE OF \$500.
- (2) THE COMMISSION MAY WAIVE OR REDUCE THE ANNUAL FEE FOR A VOLUNTEER FIRE COMPANY OR A VOLUNTEER RESCUE COMPANY.
- (3) LICENSE FEES COLLECTED UNDER THIS SUBSECTION SHALL BE CREDITED TO THE GENERAL FUND OF THE COUNTY.
- (N) (M) (1) A WHOLESALER'S LICENSE EXPIRES ON THE FIRST JULY 1 THAT COMES AFTER THE EFFECTIVE DATE OF THE WHOLESALER'S LICENSE.
