(2) A HOLDER OF A WHOLESALER'S LICENSE MAY NOT SELL A TIP JAR ~~DEVICE~~ PACKET ONLY TO A HOLDER OF ANY PERSON WHO DOES NOT HOLD A TIP JAR LICENSE.

~~(O)~~ (O) A VOLUNTEER FIRE COMPANY OR A VOLUNTEER RESCUE COMPANY MAY HOLD BOTH A TIP JAR LICENSE AND A WHOLESALER'S LICENSE.

~~(P)~~ ~~(Q)~~ (P) (1) THERE IS A WASHINGTON COUNTY GAMING FUND ESTABLISHED BY THE COMMISSION.

(2) IN THIS SUBSECTION, "GROSS PROFITS" MEANS THE TOTAL PROCEEDS FROM THE OPERATION OF A TIP JAR LESS THE AMOUNT OF PRIZES OR MONEY WINNINGS DISTRIBUTED.

(I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, A PERSON THAT IS A HOLDER OF QUALIFIES FOR A TIP JAR LICENSE UNDER SUBSECTION (F)(1)(V) OR (VI), (VI), OR (VII) OF THIS SECTION SHALL DEPOSIT WITH A BANK FINANCIAL INSTITUTION THAT THE COMMISSION DESIGNATES AND TO THE CREDIT OF THE FUND:
