Emergency Bill No. 5-94

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS, SECTION 3.40 OF ARTICLE VII "CONDITIONAL USE", SECTION 2.40 OF ARTICLE X "DEFINITIONS", AND ADDING NEW SECTION 7 TO ARTICLE VI "SPECIAL PROVISIONS" AND NEW SECTION 140.a TO ARTICLE X "DEFINITIONS" AND CHANGING SECTION 2.6B.7, SECTION 4.6C.7, SECTION 6.6C.7, SECTION 9B6 AND SECTION 10.16.7 OF THE KENT COUNTY ZONING ORDINANCE DEFINING PUBLIC UTILITY LINES AND ACCESSORY USES AND REDEFINING PUBLIC UTILITIES AND MAKING "PUBLIC UTILITY LINES AND ACCESSORY STRUCTURES" PERMITTED USES IN AZD, RCD, RR, CAR, V, LM, IM, AND AHD DISTRICTS, FURTHER PROVIDING THAT "PUBLIC UTILITIES" SHALL BE CONDITIONAL USES IN AZD, RCD, RR, CAR, V, LM, IM, AND AHD DISTRICTS.

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS AND RECODIFY THE PUBLIC LOCAL LAWS OF KENT COUNTY, MARYLAND, BEING THE 1989 CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY, MARYLAND, AS AMENDED FROM TIME TO TIME, SAVING FROM REPEAL ALL LEGISLATION ADOPTED SUBSEQUENT TO MARCH 1, 1994, AND ANY AND ALL ACTIONS OR CAUSES OF ACTIONS, CONTRACTS AND RIGHTS ACCRUED UNDER THE LEGISLATION EXISTING PRIOR HERETO, AND MAKING CERTAIN SUBSTANTIVE AND STYLISTIC CHANGES INCLUDING PENALTIES FOR VARIOUS INFRACTIONS. THE NUMBERING SYSTEM USED HEREIN FOLLOWS THE CODIFICATION NUMBERING SYSTEM. COPIES OF THE RECODIFIED CODE OF PUBLIC LOCAL LAWS ARE AVAILABLE IN THE COUNTY COMMISSIONERS OFFICE.
