schedule may be made during the fiscal year in accordance with the provisions of Sections 6-108 and 6-109 of the State Personnel and Pensions Article. Notwithstanding the inclusion of salaries for positions which are determined by agencies with independent salary setting authority in the salary schedule set forth below, such salaries may be adjusted during the fiscal year in accordance with such salary setting authority.

Further, it is the intent of the General Assembly that the minimum amount of a salary increase for an individual promoted to or within the executive pay plan should be 3% and the maximum amount should be 6% unless otherwise approved by the Board of Public Works.

Further, it is also the intent of the General Assembly that the effective date of an executive salary adjustment shall not precede the date upon which the Board of Public Works approved the salary adjustment.
