~~(F) (1) THE COMMUNITY SERVICE COORDINATOR MAY, WITHIN 30 DAYS AFTER THE CITATION WAS ISSUED, FILE A COMPLAINT WITH THE INTAKE OFFICER UNDER § 3-810 OF THIS ARTICLE IF:~~

~~(I) THE COMMUNITY SERVICE COORDINATOR DETERMINES THAT COMMUNITY SERVICE UNDER THIS SECTION WOULD BE INAPPROPRIATE FOR THAT CHILD; OR~~
