FOR the purpose of authorizing the creation of a State Debt not to exceed \$2,500,000 \$500,000, the proceeds to be used as a grant to the Board of Directors of the Constellation Foundation, Inc. for certain acquisition, development, or improvement purposes; providing for disbursement of the loan proceeds, subject to a requirement that the grantee provide and expend a matching fund; requiring the grantee to petition the Secretary of the United States Navy to grant and convey to the Maryland Historical Trust a historic easement; certain easements or covenants; and providing generally for the issuance and sale of bonds evidencing the loan; and amending Chapter 287 of the Acts of the General Assembly of 1995, the U.S.S. Constellation Loan of 1995, to alter the method of providing the matching fund and to make technical changes.

BY repealing and reenacting, with amendments,

Chapter 287 of the Acts of the General Assembly of 1995 Section 1

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

- (1) The Board of Public Works may borrow money and incur indebtedness on behalf of the State of Maryland through a State loan to be known as the Baltimore City U.S.S. Constellation Loan of 1996 in a total principal amount equal to the lesser of (i) \$2,500,000 \$500,000 or (ii) the amount of the matching fund provided in accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of State general obligation bonds authorized by a resolution of the Board of Public Works and issued, sold, and delivered in accordance with §§ 8–117 through 8–124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- (2) The bonds to evidence this loan or installments of this loan may be sold as a single issue or may be consolidated and sold as part of a single issue of bonds under § 8-122 of the State Finance and Procurement Article.
- (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, for the following public purposes, including any applicable architects' and engineers' fees: as a grant to the Board of Directors of the Constellation Foundation, Inc. (referred to hereafter in this Act as "the grantee") for the design, repair, restoration, improvement, and preservation of the U.S.S. Constellation.
- (4) An annual State tax is imposed on all assessable property in the State in rate and amount sufficient to pay the principal of and interest on the bonds, as and when due and until paid in full. The principal shall be discharged within 15 years after the date of issuance of the bonds.
 - (5) (a) The grantee shall provide and expend a matching fund.
- (b) No part of the grantee's matching fund may be provided, either directly or indirectly, from funds of the State, whether appropriated or unappropriated. No part
