**CHAPTER 582**

**(Senate Bill 410)**

AN ACT concerning

**Trademark Counterfeiting**

FOR the purpose of creating the criminal offense of trademark counterfeiting; ~~establishing that certain registration of certain intellectual property is prima facie evidence of a trademark or trade name; making certain items subject to seizure by a law enforcement officer for a certain purpose providing for the seizure and transfer of certain items to the owner of intellectual property under certain circumstances; establishing a certain statute of limitations for certain actions or prosecutions; establishing that certain registration of certain intellectual property is prima facie evidence of a trademark or trade name; making certain items subject to seizure by a law enforcement officer for a certain purpose,~~ establishing certain penalties; defining certain terms; and generally relating to the criminal offense of trademark counterfeiting.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

**Article 27 – Crimes and Punishments**

48A.

(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) “COUNTERFEIT MARK” MEANS:

(I) AN UNAUTHORIZED REPRODUCTION OR COPY OF INTELLECTUAL PROPERTY; OR

(II) INTELLECTUAL PROPERTY AFFIXED TO ITEMS KNOWINGLY SOLD, OFFERED FOR SALE, MANUFACTURED, OR DISTRIBUTED, OR IDENTIFYING SERVICES OFFERED OR RENDERED, WITHOUT THE AUTHORITY OF THE OWNER OF THE INTELLECTUAL PROPERTY.
