- (2) Designate the Warden of the Kent County Detention Center as the agent to collect these costs.
- (C) (1) THE KENT COUNTY COMMISSIONERS MAY ESTABLISH THE FOLLOWING PROGRAMS UNDER THE KENT COUNTY DETENTION CENTER:
 - (I) PRETRIAL RELEASE;
 - (II) WORK RELEASE;
 - (III) COMMUNITY SERVICE; AND
 - (IV) HOME DETENTION.
- (2) THE KENT COUNTY COMMISSIONERS SHALL ADOPT REGULATIONS NECESSARY TO IMPLEMENT THE PROGRAMS ESTABLISHED UNDER THIS SECTION.
- (D) IN KENT COUNTY, WHEN AN INDIVIDUAL WHO HAS NO OTHER CHARGES PENDING IN ANY JURISDICTION IS SENTENCED TO THE CUSTODY OF THE WARDEN OF THE KENT COUNTY DETENTION CENTER, THE COURT MAY, AT THE TIME OF SENTENCING OR AT ANY TIME DURING THE INDIVIDUAL'S INCARCERATION, PRESCRIBE THAT THE INDIVIDUAL MAY PARTICIPATE IN ANY OF THE PROGRAMS ESTABLISHED UNDER THIS SECTION.
- (E) AN INDIVIDUAL WHO HAS BEEN DESIGNATED TO PARTICIPATE IN ANY OF THE PROGRAMS LISTED UNDER SUBSECTION (A) OF THIS SECTION MAY BE GRANTED THE PRIVILEGE OF LEAVING THE KENT COUNTY DETENTION CENTER TO:
 - (1) CONTINUE THE INDIVIDUAL'S REGULAR EMPLOYMENT: OR
 - (2) SEEK NEW EMPLOYMENT; OR
 - (3) RECEIVE THERAPY FOR DRUG OR ALCOHOL ADDICTION.
- (F) (1) THE INCOME OF AN INDIVIDUAL WHO HAS BEEN DESIGNATED TO PARTICIPATE IN A WORK RELEASE PROGRAM, LESS PAYROLL DEDUCTIONS REQUIRED BY LAW, SHALL BE COLLECTED BY OR SURRENDERED TO THE WARDEN OR THE WARDEN'S DESIGNEE.
- (2) FROM THE INCOME OF THE INDIVIDUAL, THE WARDEN SHALL DEDUCT AND DISBURSE THE FOLLOWING:
- (I) THE AMOUNT DETERMINED BY THE WARDEN TO BE THE COUNTY'S COST FOR PROVIDING FOOD, LODGING, AND CLOTHING FOR THE INDIVIDUAL;
- (II) ACTUAL AND NECESSARY FOOD, TRAVEL, AND OTHER EXPENSES INCURRED BY THE COUNTY INCIDENTAL TO THE INDIVIDUAL'S PARTICIPATION IN THE PROGRAM:
- (III) ANY AMOUNTS IMPOSED BY THE COURT FOR FINES, COSTS, AND RESTITUTIONS;
