  - (1) OTHERWISE IS ENTITLED TO BE <del>LICENSED</del> <u>CERTIFIED</u>;

- (D) (1) EACH <u>LICENSE CERTIFICATE</u> HOLDER SHALL NOTIFY THE BOARD IN WRITING OF ANY CHANGE IN THE NAME OR ADDRESS OF THE <u>LICENSE</u> CERTIFICATE HOLDER WITHIN 60 DAYS AFTER THE CHANGE OCCURRED.
- (2) IF A <u>HCENSE CERTIFICATE</u> HOLDER FAILS TO NOTIFY THE BOARD WITHIN THE TIME REQUIRED UNDER THIS SUBSECTION, SUBJECT TO THE HEARING PROVISIONS OF <u>\$ 8-317</u> § 3-315 OF THIS TITLE, THE BOARD MAY IMPOSE AN ADMINISTRATIVE PENALTY OF \$100.
- (E) THE BOARD SHALL RENEW THE <u>LICENSE CERTIFICATE</u> OF EACH <u>LICENSE CERTIFICATE</u> HOLDER WHO MEETS THE REQUIREMENTS OF THIS SECTION.
