CHARTER AMENDMENT RESOLUTION NO. 48/95

A CHARTER AMENDMENT RESOLUTION OF THE COMMISSIONERS OF THE TOWN OF CHURCH HILL, MARYLAND AMENDING SECTION 519 "PURCHASES AND CONTRACTS" OF THE CHARTER OF THE TOWN OF CHURCH HILL, MARYLAND TO AUTHORIZE THE TOWN COMMISSIONERS TO WAIVE THE ADVERTISING REQUIREMENTS OF THE BID PROCESS FOR GOOD CAUSE SHOWN AND TO INCREASE THE AMOUNT OF A CONTRACT REQUIRED FOR COMPETITIVE BIDDING FROM \$1,000 TO \$5,000.

Charter Resolution 95-CR-3

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF COLLEGE PARK, MARYLAND TO AMEND SUBSECTION C4-5 (PETITIONS FOR CANDIDACY) OF THE CITY CHARTER IN ORDER TO RESTRICT CANDIDATES TO RUNNING FOR ONLY ONE OFFICE, TO REQUIRE CANDIDATES TO FILE WRITTEN AUTHORIZATION FOR THEIR CANDIDACY AND TO REQUIRE EMPLOYEES WHO RUN FOR CITY OFFICE TO TAKE AN UNPAID LEAVE OF ABSENCE.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF COLLEGE PARK, MARYLAND ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF COLLEGE PARK BY ANNEXING LAND CONTIGUOUS AND ADJOINING THE EXISTING CORPORATE AREA OF THE CITY OF COLLEGE PARK LOCATED SOUTH OF THE BELTWAY, WEST OF U.S. ROUTE 1, NORTH OF THE SOUTHERLY RIGHT OF WAY LINE OF CHERRY HILL ROAD AND EAST OF A PARK OWNED BY THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION, CONSISTING OF 24.5078 ACRES, MORE
