CHARTER AMENDMENT RESOLUTION NO. 1995-1

SUBJECT: "Passage of ordinances." Resolution of the Mayor and City Council of Ocean City, adopted pursuant to the authority of Article XI-E of the Constitution of Maryland, and Section 13 of Article 23A of the Annotated Code of Maryland, 1957 edition as amended, to amend the Charter of the Town of Ocean City, Maryland, the amendment to be entitled: Section C-409 "Passage of Ordinances" by repealing and reenacting with amendment certain sections of the Charter of the Town of Ocean City, Maryland. This amendment shall have the effect of permitting a fair summary of any ordinance to be published and the complete text posted before passage.
