15-1306. POWERS AND DUTIES OF COMMITTEE.

- (A) EVALUATION OF LEGISLATIVE PROPOSALS AND STATUTES.
- (1) AT THE REQUEST OF THE GOVERNOR OR THE LEGISLATIVE POLICY COMMITTEE, THE INTERDEPARTMENTAL COMMITTEE SHALL EVALUATE LEGISLATIVE PROPOSALS AND STATUTES THAT ESTABLISH, EXPAND, OR REPEAL MANDATED HEALTH INSURANCE BENEFITS OR, EXCEPT AS OTHERWISE PROVIDED BY LAW, NONDISCRIMINATION PROVISIONS, AND BENEFICIARY OR LENGTH OF COVERAGE PROVISIONS.
- (2) ON OR BEFORE MAY 31 OF EACH YEAR, THE GOVERNOR OR THE LEGISLATIVE POLICY COMMITTEE SHALL NOTIFY THE INTERDEPARTMENTAL COMMITTEE OF THE EVALUATIONS THAT MUST BE COMPLETED BEFORE THE NEXT REGULAR SESSION OF THE GENERAL ASSEMBLY.
 - (B) APPOINTMENT OF EXPERT REVIEW PANELS.

THE COMMITTEE SHALL:

- (1) APPOINT OBJECTIVE EXPERT REVIEW PANELS TO EVALUATE LEGISLATIVE PROPOSALS OR STATUTES REFERRED TO THE COMMITTEE FOR REVIEW; AND
 - (2) DESIGNATE A CHAIRMAN FOR EACH PANEL.

REVISOR'S NOTE: This section is new language derived without substantive change from former Art. 48A, § 490M(c)(1) and (2) and (d).

In subsection (a)(2) of this section, the word "Interdepartmental" is added to modify "Committee" for clarity and to distinguish the Interdepartmental Committee from the Legislative Policy Committee.
