27-702. PURPOSE OF SUBTITLE; ADDITIONAL POWER; LIBERAL CONSTRUCTION.

(A) PURPOSE OF SUBTITLE.

- (1) THE GENERAL ASSEMBLY DECLARES THAT IT IS IN THE INTEREST OF CITIZENS OF THE STATE WHO BUY INSURANCE FROM UNAUTHORIZED INSURERS THAT SOLICIT BUSINESS IN THE STATE BY PLACING IN OR SENDING INTO THE STATE FALSE ADVERTISING DESIGNED TO INDUCE RESIDENTS OF THE STATE TO BUY INSURANCE FROM THEM, THAT THOSE UNAUTHORIZED INSURERS BE SUBJECT TO THIS SUBTITLE.
- (2) THE PURPOSE OF THIS SUBTITLE IS TO SUBJECT TO THE JURISDICTION OF THE COMMISSIONER AND THE COURTS OF THE STATE THOSE UNAUTHORIZED INSURERS DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION.
