

PERMIT, IF AN APPLICANT, REGISTRANT, OR PERMIT HOLDER, OR AN AGENT, EMPLOYEE, OFFICER, DIRECTOR, OR PARTNER OF THE APPLICANT, REGISTRANT, OR PERMIT HOLDER:

(1) FRAUDULENTLY OR DECEPTIVELY OBTAINS OR ATTEMPTS TO OBTAIN A REGISTRATION OR PERMIT;

(2) FRAUDULENTLY OR DECEPTIVELY USES A REGISTRATION OR PERMIT;

(3) IS CONVICTED OF A FELONY, THEFT OFFENSE, OR CRIME OF MORAL TURPITUDE;

(4) FAILS TO PROVIDE OR MISREPRESENTS ANY INFORMATION REQUIRED TO BE PROVIDED UNDER THIS TITLE;

(5) VIOLATES THIS TITLE;

(6) VIOLATES THE CODE OF ETHICS ADOPTED BY THE DIRECTOR;

(7) VIOLATES A REGULATION ADOPTED UNDER THIS TITLE;

(8) FAILS TO ~~ADEQUATELY SUPERVISE~~ PROVIDE REASONABLE AND ADEQUATE SUPERVISION OF THE OPERATION OF THE CEMETERY OR THE PROVISION OF BURIAL GOODS BY AGENTS, EMPLOYEES, OFFICERS, DIRECTORS, OR PARTNERS AFFILIATED WITH A CEMETERY OR BURIAL GOODS BUSINESS;

(9) REFUSES TO ALLOW AN INSPECTION REQUIRED BY THIS TITLE;

(10) FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR;

(11) FAILS TO COMPLY WITH ANY TERMS OF SETTLEMENT UNDER A BINDING ARBITRATION AGREEMENT; OR

(12) IS FOUND GUILTY BY A COURT IN THIS STATE OF VIOLATING AN UNFAIR AND DECEPTIVE TRADE PRACTICES PROVISION UNDER TITLE 13 OF THE COMMERCIAL LAW ARTICLE.

(B) (1) IF A REGISTRANT OR PERMIT HOLDER IS CHARGED WITH A VIOLATION OF THIS TITLE THAT COULD RESULT IN SUSPENSION OR REVOCATION OF THE REGISTRATION OR PERMIT, THE DIRECTOR MAY SEEK AN IMMEDIATE RESTRAINING ORDER IN A CIRCUIT COURT IN THIS STATE TO PROHIBIT THE REGISTRANT OR PERMIT HOLDER FROM ENGAGING IN THE OPERATION OF ANY CEMETERY OR BURIAL GOODS BUSINESS.

(2) THE RESTRAINING ORDER IS IN EFFECT UNTIL:

(I) THE COURT LIFTS THE ORDER; OR

(II) THE CHARGES ARE ADJUDICATED OR DISMISSED.

(C) IF A REGISTRANT OR PERMIT HOLDER IS CHARGED WITH A VIOLATION OF THIS TITLE THAT COULD RESULT IN SUSPENSION OR REVOCATION OF THE REGISTRATION OR PERMIT, THE DIRECTOR MAY PETITION A COURT TO:
