CONCERNING A SPECIFIC CHILD SEXUAL OFFENDER if the [agency] DEPARTMENT determines that such notice is necessary to protect the public [interest] CONCERNING A SPECIFIC CHILD SEXUAL OFFENDER:

- (i) A community organization;
- (ii) A religious organization; [and]
- (iii) Any other organization that relates to children or youth; AND
- (IV) ANY OTHER PERSON OR ORGANIZATION THAT THE DEPARTMENT DETERMINES MAY SERVE TO PROTECT THE PUBLIC CONCERNING A SPECIFIC CHILD SEXUAL OFFENDER.
- (4) IN ADDITION TO THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES, A LOCAL LAW ENFORCEMENT AGENCY MAY ALSO MAKE THE DISCLOSURES REQUIRED UNDER THIS SUBSECTION.
- \(\frac{1}{4}\)\(\frac{15}{15}\) (I) A local law enforcement agency AND THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES shall establish procedures for carrying out the notification requirements of paragraph (3) of this subsection, including the circumstances under and manner in which notification shall be provided.
- (II) A LOCAL LAW ENFORCEMENT AGENCY AND THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES MAY NOT RELEASE THE IDENTITY OF A VICTIM OF AN OFFENSE THAT REQUIRES REGISTRATION UNDER THIS SECTION.
- $\ensuremath{(6)}$ $\ensuremath{(5)}$ A DISCLOSURE UNDER THIS SUBSECTION MAY NOT BE CONSTRUED TO LIMIT OR PROHIBIT ANY OTHER DISCLOSURE PERMITTED OR REQUIRED UNDER LAW.
- (E) (I) EXCEPT FOR A REGISTRATION STATEMENT PROVIDED TO A LAW ENFORCEMENT AGENCY, A REGISTRATION STATEMENT PROVIDED TO A PERSON OR ORGANIZATION UNDER THIS SECTION SHALL INCLUDE THE COMPLETED REGISTRATION FORM AND A COPY OF A PHOTOGRAPH OF THE CHILD SEXUAL OFFENDER, BUT NEED NOT INCLUDE THE OFFENDER'S FINGERPRINTS.
- (II) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL PROVIDE A LOCAL LAW ENFORCEMENT AGENCY WITH THE COMPLETED REGISTRATION FORM AND THE CHILD SEXUAL OFFENDER'S PHOTOGRAPH AND FINGERPRINTS, THE CHILD SEXUAL OFFENDER'S FINGERPRINTS, AND AN ACTUAL PHOTOGRAPH OF THE CHILD SEXUAL OFFENDER.
- [(5)](7) (8) (7) An elected public official, public employee, or public agency is immune from civil liability for damages arising out of any action relating to the provisions of this subsection, unless it is shown that the official, employee, or agency acted with gross negligence or in bad faith.
