## Bill No. 627

A BILL TO AMEND THE TALBOT COUNTY CODE BY ADDING ARTICLE 29. FOREST CONSERVATION, WHICH PROHIBITS CERTAIN DEVELOPMENT PROJECTS FROM CUTTING OR CLEARING CERTAIN FORESTS WITHIN TALBOT COUNTY UNLESS A FOREST STAND DELINEATION AND A FOREST CONSERVATION PLAN ARE IN EFFECT.

# Bill No. 628

A BILL TO REPEAL AND REENACT SECTION 19.13(c)(2) OF TITLE 19. ZONING, OF THE TALBOT COUNTY CODE, TO REMOVE MOBILE HOMES AND MANUFACTURED HOMES FROM THE LIST OF USES, ALLOWING NONCONFORMING IMPROVED LOTS OF RECORD WITH MOBILE HOMES AND OR MANUFACTURED HOMES TO BE SUBDIVIDED EXCEPTING MOBILE HOME OR MANUFACTURED HOME PARKS.
