- (C) IN ADDITION TO THE REQUIREMENTS OF SUBSECTION (B) OF THIS SECTION, THE BOARD SHALL PROVIDE APPROPRIATE AND ACCESSIBLE INTERNET LINKS FROM THE BOARD'S INTERNET SITE:
- (1) TO THE EXTENT AVAILABLE, TO THE APPROPRIATE PORTION OF THE INTERNET SITE OF EACH HEALTH MAINTENANCE ORGANIZATION LICENSED IN THIS STATE WHICH WILL ALLOW THE PUBLIC TO ASCERTAIN THE NAMES OF THE PHYSICIANS AFFILIATED WITH THE HEALTH MAINTENANCE ORGANIZATION; AND
- (2) TO THE APPROPRIATE PORTION OF THE INTERNET SITE OF THE AMERICAN MEDICAL ASSOCIATION.
  - (C) (D) THE BOARD:
- (1) ON RECEIPT OF A WRITTEN REQUEST FOR A LICENSEE'S PROFILE FROM ANY PERSON, SHALL FORWARD A WRITTEN COPY OF THE PROFILE TO THE PERSON; AND
- (D) (E) SUBJECT TO SUBSECTION (E) SUBSECTION (F) OF THIS SECTION, BEFORE MAKING A PROFILE <u>INITIALLY</u> AVAILABLE TO THE PUBLIC UNDER SUBSECTION (C) (D) OF THIS SECTION, THE BOARD SHALL:
