- (C) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE OF \$5,000 FOR EACH VIOLATION OF THIS SECTION NOT TO EXCEED \$1,000 FOR ALL VIOLATIONS CITED ON A SINGLE DAY.
 - (2) EACH VIOLATION OF THIS SECTION IS A SEPARATE OFFENSE.
- (D) (1) AN INDIVIDUAL-LICENSEE WHO VIOLATES THIS SECTION IS SUBJECT TO IMMEDIATE SUSPENSION OF THE INDIVIDUAL'S LICENSE.
- (2) THE HOLDER OF THE BEAUTY SALON PERMIT FOR THE BEAUTY SALON IN WHICH THE VIOLATION OCCURRED IS SUBJECT TO IMMEDIATE SUSPENSION OF THE BEAUTY SALON PERMIT.
- (3) BEFORE A LICENSE OR PERMIT SUSPENDED UNDER THIS SUBSECTION MAY BE REINSTATED, THE BOARD SHALL HOLD A HEARING ON THE VIOLATION.
- (<u>H</u>) (<u>H</u>) THE BOARD MAY IMMEDIATELY SUSPEND A LICENSE OF AN INDIVIDUAL IF THE BOARD REASONABLY BELIEVES THAT THE LICENSEE VIOLATED THIS SECTION.
- (2) IMMEDIATELY FOLLOWING A SUSPENSION UNDER THIS SUBSECTION, THE BOARD SHALL HOLD A HEARING IN ACCORDANCE WITH § 5 315 OF THIS TITLE TO DETERMINE:
 - (I) WHETHER THE LICENSEE VIOLATED THIS SECTION; AND
- (II) THE APPROPRIATE LENGTH OF THE SUSPENSION IF THE BOARD DETERMINES THAT THE LICENSEE DID VIOLATE THIS SECTION.
- (3) IF, AFTER THE HEARING, THE BOARD DETERMINES THAT THE INDIVIDUAL WHOSE LICENSE WAS SUSPENDED UNDER THIS SUBSECTION DID NOT VIOLATE THIS SECTION, THE BOARD SHALL IMMEDIATELY REINSTATE THE INDIVIDUAL'S LICENSE.
- (E) (1) THE BOARD MAY IMMEDIATELY SUSPEND A BEAUTY SALON PERMIT IF THE BOARD REASONABLY BELIEVES THAT A VIOLATION OF THIS SECTION OCCURRED IN THE BEAUTY SALON.
- (2) <u>IMMEDIATELY</u> <u>FOLLOWING A SUSPENSION UNDER THIS SUBSECTION, THE BOARD SHALL HOLD A HEARING IN ACCORDANCE WITH § 5–523 OF THIS TITLE TO DETERMINE:</u>
- <u>(I) WHETHER A VIOLATION OF THIS SECTION OCCURRED IN THE BEAUTY SALON OF THE PERMIT HOLDER; AND</u>
- (II) THE APPROPRIATE LENGTH OF THE SUSPENSION IF THE BOARD DETERMINES THAT A VIOLATION OF THIS SECTION DID OCCUR IN THE BEAUTY SALON OF THE PERMIT HOLDER
