~~(a) Each policy of group health insurance shall contain [in substance the provisions of this section] PROVISIONS THAT IN THE OPINION OF THE COMMISSIONER ARE AT LEAST AS FAVORABLE TO THE POLICYHOLDER OR INSURED AS THE PROVISIONS IN THIS SECTION.~~

~~(b) Each policy of group health insurance shall contain a provision that[, absent fraud, each statement made by an applicant, policyholder, or insured is considered to be a representation and not a warranty].~~

~~(1) THE POLICY AND APPLICATION CONSTITUTE THE ENTIRE CONTRACT BETWEEN THE PARTIES;~~

~~(2) ABSENT FRAUD, EACH STATEMENT MADE BY AN APPLICANT, POLICYHOLDER, OR INSURED IS CONSIDERED TO BE A REPRESENTATION AND NOT A WARRANTY, AND~~
